

with all parties having the right to present their views and/or evidence. Upon hearing the case, the Fair Board will make a ruling.

When satisfactory evidence has been obtained by the Fair Board that any of the livestock rules have been violated, the exhibitor and/or exhibitor's family may be barred from showing in any future agricultural fairs. The minimum number of years for a disbarment is three (3) years before the right to a review. In case any premium shall have been awarded to animals shown in violation of this rule, the Fair Board will require the exhibitor to refund all premiums, trophies, awards, ribbons and sale money under each violation. Unless fraud and/or deception are involved, all championship placings stand.

**CODE OF PRACTICES**

- The following describes general responsibilities of the farmer and all persons in their authority, in the proper care and handling of animals raised for food and fiber.
- To provide food, water and care necessary to protect the health and welfare of my animals.
- To provide a safe and healthy environment for my animals, that is clean, well ventilated and provides ample space.
- To provide a well planned disease prevention program to protect the health of my herd or flock. This includes a strong veterinarian/client relationship.
- To use humane and sanitary methods when it becomes necessary to dispose of my animals.
- To make timely inspections of all animals to evaluate the

- health and ensure that all basic requirements are being met.
- To ensure proper handling techniques are used to eliminate any undue stress or injury when manual manipulation is necessary.
  - To provide transportation for my animals that avoids undue stress or injury caused by overcrowding, excessive time in transit or improper handling when loading or unloading.
  - The willful mistreatment of my animals or the mistreatment of any animal will not be tolerated. In cases of mistreatment, I will notify the proper authorities.
  - To make management decisions based on scientific fact and to consider the welfare of my animals.

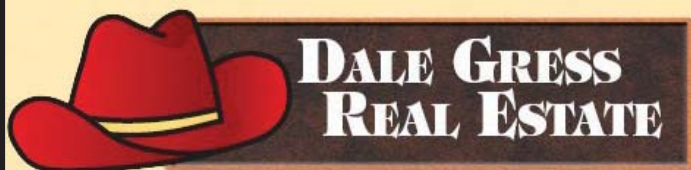

All animals must remain on exhibit until 12 noon Thursday or no premiums will be paid. Horses to compete for premiums must be sound, except in cases of stallions or mares injured by accident which does not impair them for breeding purposes.

Each horse or pony is to be assigned an individual number when entry is made.

All horses or ponies exercised in the riding arena are to be led to and from the arena.

4-H horses are to be stabled in the 4-H barn.

All horses or ponies must be entered in their proper classes and division.

All classes are open to all light horse and pony breeds, registered and non-registered. Pony height shall be under 58" and Horse height shall be 58" and over.

**EXHIBITORS WHO DO NOT ABIDE BY THE RULES OF THE DEPARTMENT WILL BE BARRED FROM EXHIBITING OR SHOWING FOR A PERIOD OF THREE (3) YEARS.**

When animals are of an inferior quality, the judges shall refuse to award premiums even though there is no other competition, and in any case where the animals are not deemed worthy of first premium, the judges shall not award higher than second premium. In all cases, the exhibit must be of sufficient merit to warrant an award of any kind being made.

No one will be allowed in the show ring except the officials and the ones riding or otherwise showing the horses or ponies, during the judging of the classes. Anyone interfering with the judge or other officials during the show, will be expelled from the ring, or the judge may declare the show void, at his discretion. If help is needed by the exhibitor in the ring, permissions must be obtained from the superintendent in charge.

Should any horses or ponies be entered and not shown, the stall rent will be \$10.00 per day.

Ponies and horses may be hauled in, with permission of department superintendent, so long as there are no stalls available.

All stallions to be shown by adults only. All other classes may be shown by child or adult, or as class indicates.

All exhibitors are to have animals in arena within reasonable time after class is called. Have your animals in paddock at the close of previous class.

NOTE - YOUTH BIRTHDATE AS OF JANUARY 1.

LEAD-IN AND WALK-TROT RIDERS ARE NOT ELIGIBLE FOR GAITED CLASSES.

**RULES AND REGULATIONS FOR OPEN CLASS STOCK LIVESTOCK**

Entries close 5 p.m., September 13.

All exhibitors must purchase an exhibitor's ticket or membership ticket.

An entry fee will be charged on all entries (singles and groups), to be paid to the secretary at the time of making the entry.

Each exhibitor will be limited to two entries in singles and one entry in groups.

All animals must be bona fide property of the exhibitor, except where otherwise specified.

All animals must be registered, with the exception of Dairy animals owned by county residents, and BOOK 40 CROSS BRED BEEF CATTLE. Non-registered Dairy animals may be shown by Coshocton County residents only.

Where animals are of an inferior quality, the judges shall refuse to award premiums, even though there be competition, and in any case where the animal is not deemed worthy of first premium, the judges shall not award higher than second premium. In all cases, the exhibit must be of sufficient merit to warrant an award of any kind being made.

All entries must be in place by 10 p.m. Friday, September 26, 2008.

Animals are brought on the grounds at owner's risk. The Fairboard assumes no liability for accidents, but will do anything possible to avoid them.

Exhibitors who do not abide by the rules of any department will be barred. Livestock will be released on Thursday as follows:

- 12 noon - Horses, Dairy
- 1 p.m. - Swine
- 2 p.m. - Sheep, Goats
- 3 p.m. - Beef

4 p.m. Small Animals. If exhibitor has more than one species, then all exhibits will be released at the later time.
